Purpose of the MOU

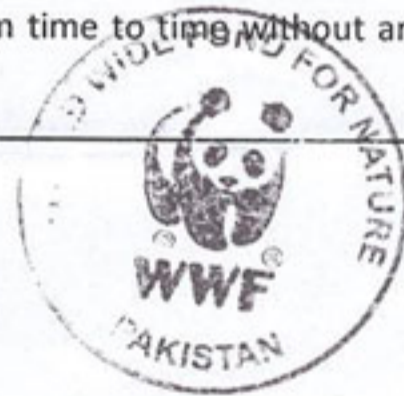

Responsibilities of ITA/IPL

- Provide timely comprehensive information about the Pakistani Education Leadership Project at Plymouth State University;
- Disburse grants for action plans as and when provided through specific programs intended for the participants and/or participating institutions;
- Facilitate follow up workshops /conferences /seminars /policy round tables and research initiatives with partner organizations;
- Organize at partners' sites or own offices alumni meetings from time to time for feedback and reflection with alumni as support groups;
- To explore all opportunities for future professional development, research opportunities and project initiatives to consolidate and expand the capabilities acquired by participating individuals and institutions
- To adhere to all national standards of professional development, policy directions in the best interest of Quality Education for All

Responsibilities of WWF-Pakistan

- Adhere to the criteria jointly developed with ITA/IPL for the selection of participants and assist in the selection process;
- Assist in preparing the necessary documents for the selected candidates travel abroad and participation in the pre-course / post-course programs including follow up reviews/conferences/seminars; also ensure timely implementation of the participants Master Action Plans(MAPS);
- Receive grant on behalf of the participant and disburse the amount as required by the participant for the implementation of Master Action Plans; monitor the progress of the participant in this regard so that agreed deadlines are met and commitments are honored.
- Host as and when possible PELI /PSU alumni meetings to be held from time to time without any location / venue charges;
