2. Following shall be the Terms of References (ToRs) for the Committee:

- a) To take stock of existing landscape of education sector (including School Education, Higher Education, Special Education and Literacy & Non-formal Basic Education) in Punjab in comparison with other regional countries/emerging economies;
- b) Carry out a comprehensive dialogue with the concerned stakeholders, gauge the existing strengths, weaknesses, opportunities, threats (SWOT) to prepare a holistic EDUCATION ROADMAP for the Province of the Punjab;
- c) Propose annual programs/projects aligned with the overall education roadmap (in each sector);
- d) Recommend quantifiable milestones/quarterly targets to be achieved under the proposed annual program/projects
- e) Develop an indicative set of indicators in each of the education sectors in Punjab to be regularly tracked with the view to successfully implement proposed programs/projects and effectively meet the requirement of the overall long term road map;
- f) To propose measures for bringing improvements in the education sector in Punjab not only in terms of access but quality as well;
- g) To suggest measures required to be adopted to make the Public Sector educational institutions self-sustainable without compromising the duty of the Government toward its citizens for imparting quality education at affordable cost;
- h) To propose ways & means to promote collaboration between Public and Private sector for better policy outcomes in the education sector;
- i) Any other proposal deemed expedient by the Committee relating to the above said ToRs.

3. The Committee shall meet frequently and necessary logistic/secretarial support shall be provided to the Committee by School Education Department. A monthly report of the Committee shall be furnished regularly for information/orders of the Chief Minister, Punjab.

4. Further necessary action may please be taken accordingly.
